## **9) General Business**

President Luke Cevolani called for any items of general business.

Vice President Steven Cataldi took the opportunity to ask that a vote of thanks be given to President Emeritus Luke Brailey, who stepped aside last month, for his fearless leadership and courage since the organisation's inception nine years ago. Mr Cataldi said that without Mr Brailey's unstinting efforts, Belmore Sports Ground would not be the facility it is today.

Community Relations & Operations Manager Joe Karam reminded the executive committee that the next biannual survey was scheduled to take place in October and will send a reminder to all volunteer leaders closer to the time to seek helpers for the four weekends of that month. Mr Karam expressed indifference that the number of those surveyed in April who would prefer to see NRL matches at Belmore was down 3% from the previous survey conducted in October 2013, attributing it to the fact that the Bulldogs have no long-term intentions to play premiership NRL games at Belmore and local residents are mindful of this, focusing their efforts on other sports to potentially fill the void left by the Bulldogs when they chose to stop playing NRL matches there in 1998.

Treasurer Oltan Akdogan conveyed his disappointment that sports like gridiron and rugby union have been excluded from using Belmore Sports Ground, reminding the executive committee that the Federal & State government funding was awarded on the proviso that the venue be used as a multi-purpose sporting facility. However, he accepted that as the primary leaseholders of the historic facility for the next 21 years, it is the Bulldogs' ultimate decision but noted that it was incongruous and unbecoming of a sporting club that prided itself on being known as the "family club" to purposely deprive genuine sporting outfits from using a community resource funded by taxpayers.

Webmaster & Social Media Co-ordinator Angus Jabbour encouraged all stakeholders to work constructively for the benefit of local sport and urged federal MP Tony Burke and Canterbury City Council General Manager Jim Montague to be more pro-active in promoting other sports at Belmore Sports Ground, stating that not all taxpayers and ratepayers who funded the venue's upgrades were necessarily supporters of rugby league and soccer.

There being no further general business to discuss, Luke Cevolani closed the meeting at 9.02 pm
